January 30, 2012

The Talbot County Board of Commissioners held a Called Meeting on Monday, January 30, 2012 at 6:00 p.m. The meeting was held at the County Commission Office, located at 74 West Monroe Street, Talbotton, Georgia. All Commissioners were present, with the exception of Vice Chairman Holmes, who had a previous engagement. The County Attorney, County Manager, and the County Clerk/Assistant County Manager were also in attendance.

Chairman Freeman Montgomery called the Meeting to order, and led everyone in a moment of silence, and the recitation of the "Pledge of Allegiance."

The bonus status change was discussed, but no decision was made.

The County Manager presented a bid From A-Com Security for \$6,630.00, to install security cameras at the Tax Assessor's Office, Senior Center, Recreation Department, and the County Commission Office.

No decision was made at this meeting, but it will be on the Agenda for the February 6th Regular Board Meeting.

The Board gave the Building and Zoning Director approval to proceed with the proposed Talbot County Zoning Ordinance Amendments.

Commissioner Chapman made a motion, and Commissioner Walker seconded, for the Board to go into Executive Session at 7:00 pm, to discuss possible litigation, real estate, and personnel matters. Vote passed 3-0-0.

Chairman Montgomery called the Meeting Back to order at 8:25 pm.

Commissioner Lanier arrived during Executive Session.

No decisions were made in Executive Session.

Commissioner Chapman made a motion, and Commissioner Lanier seconded, for the Board to authorize Chairman Montgomery to negotiate a price for the purchase of the vacant Doctor's office, located in Talbotton. Vote passed 4-0-0.

Chairman Montgomery made a motion, and Commissioner Chapman seconded, for the Board to authorize Commissioner Walker to negotiate with The Peoples Bank of Talbotton for the purchase of property, eight acres, located on Highway 80. The property will be used for a recreation park. Vote passed 4-0-0.

There being no further business, Commissioner Walker made a motion for the Board Meeting to adjourn. Commissioner Lanier seconded the motion. Vote passed 4-0-0.
