The Talbot County Board of Commissioners held a Called Meeting/Work Shop on Wednesday, May 31, 2017 at 10:00 am, at the Chamber of Commerce Office, located at 95 Washington Avenue, Talbotton, Georgia. Chairperson Sher'Londa Walker, Vice Chairman Franklin Holmes, Commissioners Ken Chapman, Freeman Montgomery and Raines Jordan attended the meeting. Also in attendance was the County Manager, Carol Ison. Vice Chairman Holmes arrived late.

Chair Walker called the meeting to order at 10:05 am.

The first item of business was the proposed estimates from Vaughn & Melton Consulting Engineers, Inc., for the 2017 LMIG Project.

Following a conversation with Clayton Moore representing Vaughn & Melton Consulting Engineers, Inc., Commissioner Jordan made a motion, Commissioner Montgomery seconded, for the Board to approve continuing with the 2017 LMIG project as proposed by Vaughn & Melton Consulting Engineers, Inc. approximately \$147,600.00 will be funded with T-SPLOST revenue. The vote passed 4-0-0.

Commissioner Montgomery made a motion, Commissioner Jordan seconded, for the Board to approve the request from Road Superintendent Mike Smith to replace the culvert pipes on Callier, Horton, Kelly, and Taylor Roads. The cost to replace the pipes is \$5,233.44. The vote passed 4-0-0.

Following a discussion in reference to amending the Talbot County Personnel Policy, Commissioner Jordan made a motion, Commissioner Chapman seconded, for the Board to approve the amendments as presented. The vote passed 4-0-0.

Commissioner Jordan made a motion, Chair Walker seconded for the Board to approve Full Diesel Power in Reynolds Georgia proceeding with the repairs to the Road Department Freightliner. The repair cost is not to exceed \$8,500.00. The vote passed 4-0-0.

The County Manger presented a draft of the FYE 2018 Proposed Budget to the Board for their review and discussion.

Vice Chairman Holmes arrived at the meeting at 12:30 pm.

No decisions were made regarding the proposed budget.

There being no further business, the meeting adjourned at 2:30 pm.
