August 18, 2017

The Talbot County Board of Commissioners held a Called Meeting Friday, August 18, 2017, at 9:00 am, at the Talbot County Board of Commissioners Office, located at 74 West Monroe Street, Talbotton, Georgia.

Chairperson Sher'Londa Walker, Vice Chairman Franklin Holmes, Commissioners Freeman Montgomery and Raines Jordan attended the meeting. The County Manager, Carol Ison was also in attendance.

Chair Walker called the meeting to order.

The first item of business was the sealed bid that was received from Robinson Paving for the 2017 Local Maintenance Improvement Grant (LMIG) Project. The bid for \$566,829.64, is for road work to be done on Callier, Kelly, Horton, and Buckner Roads.

Following a discussion, and based on the recommendation of Vaughn and Melton Consulting Engineers, Chair Walker made a motion for the Board to accept the bid and award the contract to Robinson Paving Company for \$566,829.64. Commissioner Chapman seconded the motion. The vote passed 5-0-0.

The next item of business was to set the 2017 Millage Rate.

The Chairman presented the requested amount of revenue for both Talbot County and the Talbot County Board of Education (BOE). The total revenue for Talbot County is \$3,621,499.00, and for the Board of Education is \$3,146,633.00. The Board of Education's request includes Maintenance and Operations.

Talbot County's net mill rate is 15.938, the BOE's net mill rate is 14.050, and the total mill rate for 2017 is 29.988.

Following the discussion, Commissioner Montgomery made a motion for the Board to set the 2017 Millage Rate at 29.988. Vice Chairman Holmes seconded the motion. The vote passed 5-0-0.

Commissioner Montgomery made a motion, Commissioner Chapman seconded, for the Board to adopt the Resolution approving the proposed Fiscal Year End 2018 Budget at \$7,021,042.00, as presented. The vote passed 5-0-0.

Vice Chairman Holmes made a motion, Commissioner Chapman seconded, for the Board to accept the offer from Yancey Bros. Co., to purchase the 1990 12G Motor Grader, serial number 61M13686, from Talbot County for \$8,750.00. The vote passed 5-0-0.

There being no further business, Commissioner Jordan made a motion for the meeting to adjourn. Commissioner Chapman seconded the motion. The vote passed 5-0-0.
