

**TALBOT COUNTY BOARD OF ELECTIONS & REGISTRATION BOARD MEETING
SEPTEMBER 13, 2022**

- A. Call to Order/Moment of Reflection:** Mrs. Trice called the meeting to order 4:33 p.m. Present were Gladys Leonard, Sharita Trice, Wycene Willis, and Pam Bulloch. Wycene Willis did our Moment of Reflection.
- B. Approval of Agenda:** Wycene made a motion to approve the agenda. Gladys Leonard seconded and all approved.
- C. Approval of Minutes from August 9, 2022 Meeting:** Wycene made a motion to approve these minutes. Gladys seconded and all approved.
- D. County Elector Reports:** After these reports were presented, Wycene made a motion to approve these reports. Pam Bulloch seconded and all approved.
- E. S.O.S., Firefly, E-Net& Legislative Updates:** Due to the federal holiday, Veteran's Day, November 11, 2022, there were deadline changes. The new deadline for voters to validate provisional ballots is 11/14/2022. If there are any Provisional, we will handle them accordingly. Also, for voters to cure rejected absentee ballots if they failed to sign the oath or their verification information did not match, is 11/14/2022. The deadline to certify the election results is 11/15/2022 by 5:00 p.m. Our new Liaison is Amanda Deering. Mrs. Trice gave us Ms. Deering's e-mail address and her phone number. If anyone wants a list of voters, we are to refer them to the SOS website. We are to continue to check GARVIS daily.
- F. Upcoming Events:** Managers and Assistant Managers from all seven precincts will meet at the election office for training to learn how to set up voting equipment and complete paperwork. This training will be from 5:00 to 7:00 p.m. on 9/20/22. On Saturday, 9/24/22, we will have a Voter Registration Drive training. There will be an attendance of eight people. This training will be from 9:00 to 11:00 a.m. Mrs. Trice will begin L & A Testing on 09/27/22 and continue until completed. The first day to mail out absentee ballots for the November 8, 2022 General Election is 10/11/22. The registration deadline to be able to vote in the 11/8/22 General Election is also 10/11/22. This also includes any address or name changes. The election staff will work on 10/14/22 to set up for advance voting.
- G. Staffing:** Election staff will begin on 10/11/22 to mail out absentee ballots. Early Voting begins on 10/17/22 from 9:00 a.m. till 5:00 p.m. Early voting will be for three weeks, which includes two Saturdays. The two Saturdays are 10/22/22 and 10/29/22. The last day to vote early is Friday, 11/4/22. Poll worker letters have been sent out to confirm who will work the November 8, 2022 General Election.
- H. Internal Training:** All Board Members were given a handout on Proposed Constitutional Amendments and State-Wide Referendum Questions for the November 8, 2022 General Election. This is to familiarize ourselves in case a voter does not understand a question on the ballot.
- I. Cellular Poll Pads:** Mrs. Trice traveled to Newnan to deliver and pick up the new cellular poll pads. There was a total of eighteen poll pads that were brought back for our office..

- J. **Technician Services for November 8, 2022 General Election:** A technician from Dominion is scheduled for our county on Monday, 11/7/22 and will assist us through Wednesday, 11/09/22. Mrs. Trice will call to extend the days to five instead of three.
- K. **Roundtable Discussion:** Mrs. Trice will be out of the office on 9/15/22 and 9/16/22. She will also be on vacation the week of October 3rd.
- L. **Adjournment:** All voted to adjourn at 6:08 p.m.
