

**TALBOT COUNTY BOARD OF ELECTIONS & REGISTRATION BOARD MEETING  
OCTOBER 11, 2022**

- A. Call to Order/Moment of Reflection:** Mrs. Trice called the meeting to order at 4:42 p.m. Present were Sharita Trice, Gladys Leonard, Salentia Thomas, Wycene Willis, and Pam Bulloch. Gladys Leonard did our Moment of Reflection.
- B. Approval of Agenda:** Wycene Willis made a motion to approve the agenda. Gladys Leonard seconded and all approved.
- C. Approval of Minutes from September 13, 2022, Meeting:** Pam Bulloch made a motion to approve these minutes. Ms. Leonard seconded and all approved.
- D. County Elector Reports:** All reports were presented. Pam Bulloch made a motion to approve these reports. Gladys Leonard seconded and all approved.
- E. S.O.S., Firefly, E-Net & Legislative Updates:** Our new Regional Training Liaison is Tyrell Golden. Mrs. Trice reported that the election returns will no longer be taken to the Manchester State Patrol Office but to the Georgia State Patrol Office in Thomaston, Georgia. It is very important that we keep checking GARVIS daily.
- F. Appointment of Board Member:** Due to Patricia Robinson resigning from the Board of Elections, on 10/3/22 Salentia Thomas was approved by the Talbot County Commissioners and appointed as our new Board Member. Salentia will fill Mrs. Robinson's unexpired term ending 12/31/2024.
- G. Upcoming Events:** The State will expedite all registrations to be sent to our office. Registrations must be processed according to the post marked date. October 11, 2022 is the last day to register to vote or make changes for the 11/8/22 General Election. Early voting will begin 10/17/22 and end 11/4/22. October 23<sup>rd</sup> and 29<sup>th</sup> will be the Saturday voting days. Early voting hours are 9:00 a.m. through 5:00 p.m.
- H. Election Night:** A reporter from Edison Research is scheduled for Election Night. Also, a poll watcher has been assigned for the following days, October 17<sup>th</sup>, 22<sup>nd</sup>, and 29<sup>th</sup>.
- I. Internal Training:** Part Two of Webinar for Risk Limited Audit will be available. All staff are required to watch this webinar prior to the audit that will take place on 11/ 17/ 22.
- J. Training:** Advance Voting Training will be held on Friday, 10/14/22 at 2:30 p.m. Poll Worker Training will begin 10/18 – 10/25 from 6:00 p.m. through 8:00 p.m. A board member will be at this training each night to assist Mrs. Trice.
- K. Cellular Poll Pads:** A black charging cable is needed for all poll pads. The request has been submitted and should arrive by Friday, 10/14/22.
- L. GAVREO Conference:** This conference will be in February 2023 at Jekyll Island, Georgia.
- M. Technician Services:** A technician is scheduled for five days for the General Election.
- N. Roundtable Discussion:** There will be a Health & Wellness Fair on November 10, 2022. Mrs. Trice has updated our website which includes a clock countdown till Election Day.
