Sealed Bids: Sealed Bids for the construction of the **Advanced Metering Infrastructure (AMI) Improvements** will be received, by the **Talbot County Board of Commissioners**, at the **Commissioners Office, P.O. Box 155, 35 West Madison Street, Talbotton, GA 31824**, until **11:00 A.M., Thursday, July 11, 2024**, local time, at which time the Bids received will be publicly opened and read. No bid may be withdrawn after the closing time for receipt of bids for a period of sixty (60) days.

Contractor License: Any Contractor submitting a bid must be a licensed by the State of Georgia. License numbers must be written on the face of the bid envelope. No bid will be opened unless the license number is clearly shown. See Instructions to Bidders for additional bidding requirements.

Work to Be Done: The work to be done shall consist of furnishing all labor, materials, and equipment necessary to construct the proposed **Advanced Metering Infrastructure (AMI) Improvements** as described in the contract documents and specifications. In general, construction consists of replacing approximately 1,371 existing water meters with ultrasonic meters, remove & replace 970-meter boxes/lids and installation of transmitters, collectors, hardware, software, and training for advanced metering infrastructure system. This work will be awarded in one (1) contract with a **120** consecutive calendar day construction schedule.

Bonds: All bid forms must be accompanied by a Bid Bond in an amount not less than ten percent (10%) of the amount bid. The successful bidder, if awarded the Contract, will be required to furnish a Performance Bond and Payment Bond, each in the amount of one hundred percent (100%) of the Contract amount. All bonds must appear on the Treasury Department's most current Circular 570 Listing.
